Captive Nations Week is observed every third week of July. In 1959, the US Congress and President passed a special law in support of the nations of Eastern Europe and Southeast Asia, which were controlled by a totalitarian communist regime.

It seemed to us that the fall of the USSR was a triumph of freedom in Europe. But this turned out to be an illusion. Moscow replaced the hammer and sickle with the imperial eagle but remained the same chauvinistic one-party dictatorship. It enslaves the peoples of Belarus, Ukraine, Georgia, Moldova and terrorizes activists in its national republics.

We, the Free Nations League empathize with the fate of all activists — political prisoners! **We have identified 143 prisoners of conscience.** National movements - members of the League - are already protecting their rights.

- **49 of them have already received sentences** for educational, environmental, anti-war and humanitarian activities.
- **94 activists are awaiting their sentences** in pre-trial detention center.

Political prisoners in the national republics of Russia



Kevin Leak 18 years. Republic of Adygea.

The youngest person convicted of "treason."

Schoolboy. Kevin was an excellent student and was interested in ecology and medicine. He was a winner of the All-Russian Olympiads. In 2022, 16-year-old Kevin was detained on trumped-up charges of "espionage." One of 30 German citizens convicted in Russia.



Fail Alsynov 38 years. Bashkortostan.

Personal enemy of the head of the republic.

National activist, environmentalist. He defended the preservation of natural monuments from industrial development. Convicted of a trumped-up charge of "inciting hatred." Another 82 Bashkirs are being held in pre-trial detention for participating in protests against the persecution of Fail. Many of them are tortured and beaten, two were killed by Russian security forces.



Zarema Musaeva 55 years. Chechnya-Ichkeria.

Personal enemy of the head of the republic.

Judge Saidi Yangulbaeva's wife. Kidnapped by the security forces of the Head of Chechnya, Ramzan Kadyrov. He persecuted the Yangulbaev family for opposition activities. He personally beat their sons, Chechen officials publicly called for their heads to be cut off. Kadyrov's people kidnapped Zarema Musaeva and accused her of far-fetched "fraud." A woman is being held hostage to silence her sons, influential bloggers. The Yangulbayev family is one of thousands of Chechen families who have faced kidnapping, torture and intimidation at the hands of Russian authorities and their proxies in occupied Ichkeria.





A particularly sophisticated punishment is punitive medicine.

A civil activist, an authoritative shaman who called on his people to live in harmony with nature and the surrounding world, to abandon the predatory exploitation of Yakut resources in the interests of the metropolis. In 2019, he organized an extremely high-profile protest against Putin - a walking march from Yakutsk to Moscow. The authorities placed him in a psychoneurological clinic. Punitive psychiatry has been a sophisticated punishment for dissidents since the times of the USSR. Dissident isolated and subjected to medical torture.

Parvina Abuzarova 32 years. Tatarstan.

Exemplary punishment for anti-war speeches.

Blogger, clothing designer for Muslim women. She condemned the war through social networks. The Russian authorities immediately accused her of actions "against the security of the Russian Federation." Indicatively, they brought her in for questioning in her dressing gown.




